Results for this poll were collected using a sampling frame from an online panel collected by the Center for Excellence in Polling. The statewide sample is of 575 likely Minnesota voters.

The survey was conducted October 6-7, 2022. The margin of sampling error is ± 4.09 percentage points. The margin of sampling error may be higher for subgroups. Results presented may not always appear to total 100 percent due to rounding.

Data were post-stratified using weighted demographic information from the U.S. Census Bureau's Current Population Survey Voting and Registration Supplement and the state election authorities. Demographic information for actual voters in past elections was used to construct sample target weights. Opportunity Solutions Project paid for all costs associated with this survey.
